

Water Systems:

The DHHL owns four water systems.
These proposed rules would enable better management and systems in Ho'olehua, Anahola, Kawaihae and Pu'ukapu. The proposed rules would enable better management and system controls by establishing clear processes for system operations and consumer services.

Planning System:

How does the DHHL manage land?
Manage resources? Make planning and program decisions? Planning System rules propose a comprehensive method to systematically coordinate how these types of decisions are made so that there is regular engagement with beneficiaries, and predictability and consistency.


