The Pre-bid Conference was held at the Shaka Restaurant at 95-5673 Mamalahoa Highway, Naalehu, Hawaii 96722 (Relocated due to the Naahelu Community Center not being opened as scheduled). Meeting commenced at 10:10 AM. (See Attachment 1, Sign-in Sheet, for persons in attendance)

Sara Okuda (DHHL) read through the Pre-bid Conference Agenda which included Introductions, Purpose, Scope of Work, Procurement Reminders, Completion Schedule and Liquidated Damages, Questions/Answers issued by Addenda, and Deadlines. The Meeting was then open to Questions and Answers (See Attachment 2 for Pre-bid Conference Agenda).

Questions and Answers:

- Are there existing PRVs on the existing line?
 - Yes, all of which are shown on drawings with proposed replacement.
- Will geotechnical engineering report be provided?
 - Final geotechnical engineering report will be provided, anticipated completion on 4/17/2020.
- Is there a probe and grout plan for the design drawings?
 - We will check with structural engineer. Following finalization of geotechnical report, structural engineer will assess the need for revisions and a change order will be issued if needed. Bidders are to bid on the IFB package, as amended.
- Are there any archaeological sites?
 - There are no known sites.
- What is the approximate length, size, and type of pipes installed for the water main?
 Contractors are directed to the IFB to determine requested information.
- Are there any portions of the project that will need to be bored? Are the crossings to be Jack & bored or directionally bored? What are the approximate lengths and diameters of the portions to be bored?
 - Contractor is responsible for determining means and methods of construction. Contractors are directed to the IFB documents to determine requested information.
- What is the engineer's estimate?
 - The engineer's estimate will not be provided to bidders. However, the Budgeted Estimate will be stated at bid opening.

- Is there an addendum issued?
 - The Contractor is responsible for checking the State's Procurement Website for issued addenda.
- Can a copy of the plan holders list be requested?
 - DHHL does not have a plan holders list of who views the plans from the State Procurement Website.
- Is there a reason why this project is being pushed out to bid without final plans?
 - This project is being funded by Capital Improvements Program funding that requires bidding the project now in order to reach the contract award deadline.
