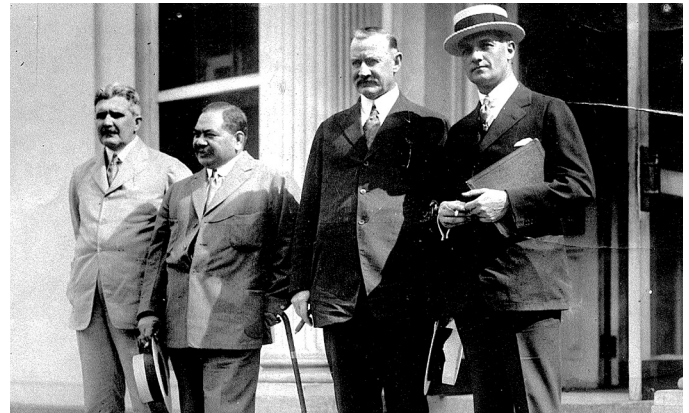

HAWAIIAN HOMES COMMISSION ACT

On July 9, 1921, the Hawaiian Homes Commission Act was signed into law as a result of an effort spearheaded by Prince Jonah Kūhiō Kalanianaʻole and a group of advocates. Through its passage, approximately 200,000 acres of land were set aside by the United States to establish a permanent homeland for native Hawaiians.

DHHL beneficiaries receive 99-year homestead leases at \$1 per year for residential, agricultural or pastoral purposes. These leases may be extended for an aggregate term not to exceed 199 years. Beneficiaries may receive financial assistance through direct loans, insured loans, or loan guarantees for home purchase, construction, home replacement, or repair.

Although DHHL's mission to develop and deliver land to native Hawaiians is well-known, the lesser known charge to manage the Hawaiian Home Lands trust effectively is equally important. Increasingly, this responsibility is demanding a greater share of DHHL's resources to address.

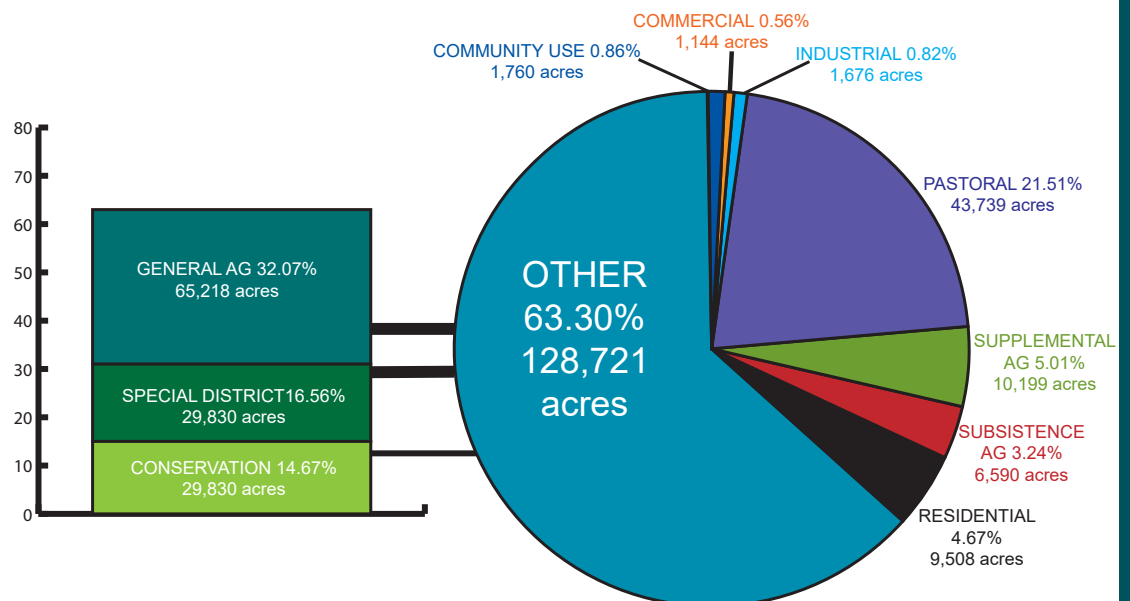

DHHL LAND INVENTORY AND LAND USE DESIGNATIONS

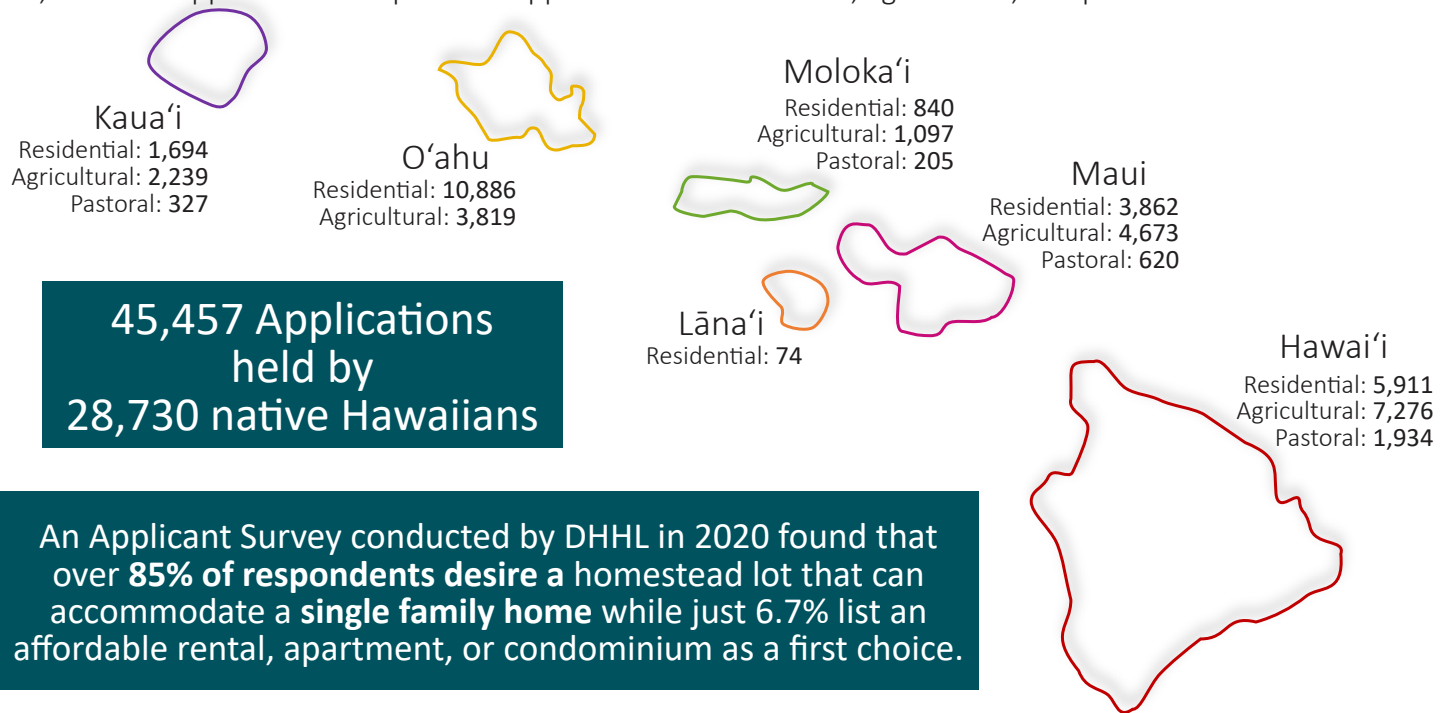

DHHL STATEWIDE APPLICATION DEMAND

Hawai'i Administrative Rules allow beneficiaries to hold a maximum of two applications, one for a residential lease and the other for either an agricultural lease or a pastoral lease. As of December 31, 2020, there are 45,457 lease applications comprised of applications for residential, agricultural, and pastoral homesteads.



ARTICLE 12 SECTION 1 - HAWAII STATE CONSTITUTION DHHL's Sufficient Funds and Executive Biennium Budget 2022 - 2023

The legislature shall make sufficient sums available for the following purposes:

- 1) development of home, agriculture, farm and ranch **lots**;
- 2) home, agriculture, aquaculture, farm and ranch **loans**;
- 3) **rehabilitation projects** to include, but not limited to, educational, economic, political, social and cultural processes by which the general welfare and conditions of native Hawaiians are thereby improved;
- 4) the **administration and operating budget** of the department of Hawaiian home lands; in furtherance of (1), (2), (3) and (4) herein, by appropriating the same in the manner provided by law.

DHHL 2021 LEGISLATIVE PROCESS

Every year, DHHL prepares and submits legislative proposals for inclusion in the Governor's Administrative Package for the next session of the Hawaii State Legislature.



July 2020	DHHL requests legislative proposals
August 2020	29 proposals received from homestead associations, lessees, staff and stakeholders. 14 of those draft proposals were selected.
September 2020	Hawaiian Homes Commission approved 13 proposals to move forward
November 2020	DHHL staff begins to prepare a draft legislative proposal for Limited Gaming
December 2020	Hawaiian Homes Commission approve proposal for Limited Gaming
January 2020	Beneficiary Consultation conducted by DHHL on Limited Gaming
