SUBJECT: Review of Intent to Award Contract to Low Bidders

I have reviewed the subject Intent to Award Contract to Low Bidders in support of the Ho‘olehua Water System Improvements, Package 4 – Furnishing and Delivery of Vehicles, Equipment and Supplies project. Per requirements in Rural Utilities Service (RUS) Bulletin 1780-34 Section 5.g – Recommendation for Award and Concurrence of Recommendation, the following shall be submitted to Rural Development (RD) for concurrence:

- A written request from the owner to RD stating at a minimum which bidder the owner wants to make award to, which bid alternates they wish to award, if any, and the proposed amount of the award.
