DHHL KĒŌKEA HOMESTEAD FARM LOTS LESSEE SURVEY RESULTS

In December, 2020, all Kēōkea Agricultural Lessees were asked to complete a survey, which they could do online or by filling out the written survey they received in the mail and returning it in the enclosed self-addressed stamped envelope. All 65 lessees received the survey, 23 (35%) completed the survey. The purpose of the survey was to get lessee data and input that would inform the development of a Master Plan for the proposed Kēōkea Community Center. This document summarizes lessee responses to the survey.

Report Format:

The Lessee responses are presented for each question in tabular and graphic form. If respondents provided additional comments in their responses, the verbatim responses are presented after the table of results. Lastly, the survey included short narrative background statements before some of the questions to ensure that all respondents had enough information to answer each question. The same narrative statements are included in this report in the colored, boxed sections.



Kēōkea Homestead Farm Lots Association (KHFLA) Survey

The Kēōkea Homestead Farm Lots Association (KHFLA) agreed upon a conceptual 10-year vision plan, born through numerous meetings over the years, that was submitted to DHHL in 2016. This plan was updated in 2019, and at that time DHHL awarded KHFLA a \$200,000 grant to do preliminary planning, Environmental Impact Assessment, Cultural Archeology area and land suitability studies. These studies will enable us to lay the foundation for the 10-year project when we are able to get the funding to build.


PBR HAWAII is the local environmental land use planning firm that is heading up this project, and this survey will allow community outreach for purposes of feedback and land use programming design.

The 10-year Vison Plan is designed to not only benefit the KHFLA, but also to benefit the surrounding Hawaiian communities. This plan will enable KHFLA to provide services and receive revenue from the various entities participating in this project.

The 10-year Vision Plan is broken down into six Phases, and the survey questions will follow along the lines of the Vision Plan structure.


Phase 1 - Malalani : Cultural Education /Native Garden Center

When the 10-year Vision plan was submitted in 2016, the area formerly known as the Nursery next to Grandma's Coffee house was overgrown and under-utilized. Due to two grants from DHHL in 2017 the area was transformed into a native plant garden, farmers market and association meeting area. We have accomplished much but wish to continue to expand.

We wish to connect the present area to Ka'amana Street via walking trail and maintenance road. As proposed, the Cultural Education/Native Garden Center area would include Food planting areas for Kalo, 'Uala, Mai'a, Kō, etc. Alongside would be Lā'au Lapa'au (Medicinal) plants. This area would enable homesteaders, students and parents of the planned school to learn about the planting, uses, care and maintenance of those plants.





Phase 2 - Hale Ola: Native Health and Wellness Center with Police substation


As proposed, build a Hale Ola and partner with health providers such as Hui No Ke Ola Pono. Provide an office space to Maui Police Department for a substation.



Upcountry Maui's nearest police response is from Makawao which has a 2-person substation. Response time for a High Priority incident is 10 to 15 minutes while a normal response is 30 to 45 minutes. On-site police presence would deter criminal activity such as illegal hunting, dumping of rubbish and theft in our homestead area.





Phase 5: Hale Kamali'i / Hale Kūpuna / Kula 'Ōpi'o








