1. What is the anticipated start date for this project?

<u>Response</u>: The anticipated start date is March 2023, subject to procurement and contract certification requirements.

2. Is water available for construction on site?

<u>Response</u>: There is no water source on site. Contractor is to provide their own water for construction.

3. Is Archaeological Monitoring required?

Response: Yes. Archaeological monitoring is required and is included as an 'Allowance' item in the Bid Form. The Archaeological Monitoring Plan is also included as Exhibit "B" in the Sample DHHL Contract's 'SPECIAL CONDITIONS'.

4. What are Hawaiian Electric Company's (aka MECO) Requirements?

Response: Most of the power lines are overhead, which will be installed by MECO.

5. Is a Grading Permit required?

<u>Response</u>: Yes. The Contractor's scope of work includes obtaining the necessary permits for construction.

6. Will the water system be turned over to the Department of Water Supply (DWS)? And if so, does DWS need inspections?

<u>Response</u>: Yes. A license agreement will be issued to DWS. Contractor will need to arrange inspections and approvals from DWS.

7. What is the cost estimate for this project?

<u>Response</u>: The Cost Estimate/Control Amount will not be available until after the due date and time for bids.

REVISION TO SC-22 in the SAMPLE DHHL CONTRACT'S 'SPECIAL CONDITIONS' (Attachment- S5)

* Revision highlighted in Bold

SC-22 in the Sample DHHL Contract's 'Special Conditions (Attachment- S5) shall be replaced with:

"SC-22 GEOTECHNICAL ENGINEER AND GEOTECHNICAL INVESTIGATION REPORT

The services of a geotechnical engineering firm will be retained by DHHL or the DEVELOPER. The CONTRACTOR shall work with the project geotechnical engineer, per the project's Specifications. The CONTRACTOR is responsible for coordinating with the geotechnical engineer and scheduling in advance whenever the geotechnical engineer is needed at the site for any required inspections or testing. The geotechnical engineer shall be present to observe site grading and other work concerning excavation, placing and compacting soil materials, and to take field density tests. Also, the geotechnical engineer shall perform laboratory testing of all imported soils or on-site soils to determine its acceptability for its intended use as select material or general fill material. The geotechnical engineer shall compile the daily observations, test data, test results and recommendations into a weekly submittal to the Construction Manager. The geotechnical engineer shall ensure that the geotechnical work complies with the specifications and drawings. Any additional testing or geotechnical costs caused by the CONTRACTOR'S error shall be at the CONTRACTOR'S sole expense and incidental to the contract. No separate payment shall be made. The CONTRACTOR is responsible to provide all closing documentation required by the geotechnical engineer to complete the project and close all applicable permits.

Subsurface geotechnical investigations have been made at the project site. A copy of the complete geotechnical investigation report entitled "Geotechnical Investigation Report, Puunani Homestead, Wailuku, Maui, Hawaii", dated July 17, 2019 and "Additional Seepage Recommendations for Pu'unani Subdivision", dated August 8, 2019 prepared by Hawaii Geotechnical Consulting, Inc., is available with these bid documents. The soils report and its recommendations are made part of the project specifications except where expressly modified herein.

Contract specifications shall control over soils report on contradictory requirements."
