This work will include roadway grading, asphalt concrete pavement and base, water lines, sewer lines, inlet boxes, drain lines, earth swales and drainage basins, signing and striping, electrical and telecom systems. The Contractor shall be required to furnish all labor, materials, and equipment to complete the project.

- The Apprenticeship Agreement Preference for public works projects shall be applied to this IFB, in accordance with HRS §103-55.6, concerning projects with an estimated value of more than \$250,000.
- This project is subject to Chapter 104 HRS, Department of Labor and Industrial Relations (DLIR) prevailing wages and salaries (included in the IFB);
- After bid opening and prior to award of the contract, DHHL shall verify compliance with Sections 103D-310 and 103D-328 HRS via Hawaii Compliance Express (HCE) for the bidder and all subcontractors. Therefore, the bidder and all subcontractors should register with HCE. The Instructions to register with HCE are here: http://vendors.ehawaii.gov;
- Failure by the bidder and/or any subcontractor to rectify a non-compliant status within ten business days of notification will be considered as sufficient for the disqualification of the bidder and rejection of its proposal;
