The Pre-bid Conference was held at 82 Andrews Avenue in Panaewa. Meeting commenced at 9:30 AM. (See Attachment 1, sign in sheet for members in attendance.)

Solana Rosa-Tutop (DHHL) read through the project summary (See Attachment 2 for project summary.) Summary included Introductions, Purpose, Scope of Work, Procurement reminders, Completion Schedule and Liquidated Damages, Questions/Answers and Deadlines.

Multiple site visits at the seven designated sites commenced. A walk-through was conducted by Stewart Matsunaga (DHHL), Kehaulani Quartero (DHHL), Darlene Fernandez (DHHL), and Solana Rosa-Tutop (DHHL) to familiarize prospective bidders with the various site conditions.

Clarification of Scope of Work:

82 Andrews Ave (Lot 58-B-1):

- Remove all trees on the corner of Andrews Ave and Desha Ave in Lot 58-B-1.
- Remove the utility pole on the corner of the lot. This pole has been abandoned.
- Consolidate all loose rocks in one place.
- Keep the stonewall intact.
- If the removal of the trees along the stonewall interferes with leaving the stonewall intact, then leave the trees there.

369 Desha Ave (Lot 62-B)

• Remove the utility pole located in the front yard of the lot.

162-A Kauhane Ave (Lot 176D)

- Cap off the water at the property line.
- Driveway into the property is part of this lot, therefore the driveway must be cleared of all organic and inorganic debris.

- Completed **Standard Qualification Questionnaire for Offerors (SPO Form 21)** is <u>required</u> and must be submitted to the office no later than 4:30 p.m. on November 4, 2022. Failure to complete and submit the SPO Form 21 by the designated deadline will be sufficient cause for the Department to disqualify a prospective Bidder.
- Bid Offers shall be electronically submitted via HIePRO no later than 2:00 p.m. on November 14, 2022. The **Bid Offer Form** must also be included as an attachment when submitting your offer via HIePRO. All offers shall be submitted as a lump sum amount including all applicable taxes and fees. Only offers submitted through HIePRO shall be considered for award. Award shall be based on the lowest qualified Total Base Offer Amount. Failure to submit the Bid Offer Form will be sufficient cause for the Department to disqualify a prospective Bidder.
- A performance bond and payment bond equal to one hundred per cent of the Total Base Offer Amount will be required if the Total Base Offer Amount exceeds \$50,000.
